




Key elements of European Universities by 2025









EUROPEAN APPROACH FOR THE QUALITY ASSURANCE OF JOINT PROGRAMMES





HAS YOUR AGENCY EVER IMPLEMENTED THE EXTERNAL EVALUATION OF FOREIGN UNIVERSITIES?




- Yes, our agency regularly evaluates HEIs from other countries

WHAT REASONS LED YOUR INSTITUTION TO CHOOSE A FOREIGN QUALITY ASSURANCE AGENCY INSTEAD OF A NATIONAL ONE?

External evaluation carried out by a foreign agency gives our institution more prestige and credibility

Foreign agency gives more opportunities to demonstrate our progress in QA

Foreign agency provides us with a more comprehensive report of our institution's external evaluation

Foreign agency provides us with better recommendations to improve our QA processes

External evaluation procedures are carried out more professionally, consistently and transparently by a foreign...

The criteria of evaluation used by the foreign agency are clearer

Foreign agency has better defined complaints and appeals process

The level of workload and cost placed by a foreign agency is usually lower compared to the national agency
