# CONTRACT ON THE EXTERNAL REVIEW OF THE AGENCY FOR SCIENCE AND HIGHER EDUCATION (ASHE)

#### THIS CONTRACT is made BETWEEN

(1) The Agency for Science and Higher Education (ASHE) whose head office is at Donje Svetice 38, 10 000 Zagreb (Croatia), and represented by Ms. Jasmina Havranek, hereafter referred to as ASHE

and

(2) The Agency for Quality Assurance in Higher Education and Research of Andalusia (AGAE), whose head office is at Avenida Al Nasir, n.3, planta 3a, puerta 2, E-14006 Cordoba (Spain) and represented by Mr Elias Fereres, hereafter referred to as "AGAE"

The parties agree as follows:

#### Recitals

WHEREAS in accordance with the ENQA membership provisions in Section 4 of the ENQA Regulations, ENQA member agencies are required to undergo external reviews at least once every five years;

WHEREAS ASHE has an Associate Status within ENQA (European Association for Quality Assurance in Higher Education) since December 20, 2007;

WHEREAS ASHE has an established role in the Croatian Higher Education System;

WHEREAS AGAE has agreed to organize the ASHE's external review;

NOW, THEREFORE, in consideration of the covenants herein contained, the two parties agree to the following terms and conditions established in this contract and its annexes I-II ("the contract").

#### **Article 1. The Review**

AGAE will undertake a review of ASHE in accordance with the membership regulations of ENQA, the requirements of the *European Standards and Guidelines for Quality Assurance in Higher Education* and the agreed Terms of Reference shown in Annex 1 to this contract.

#### **Article 2. Review timetable**

Both contracting parties shall respect the timetable presented under chapter 6 of the Terms of Reference.

#### Article 3. Payment of the review fee

- 3.1 The review fee will be 33.000 EUR, payable to AGAE following the signature of this contract.
- 3.2 The review fee will paid in two installments. Please see chapter 5 of the Terms of Reference for further information.
- 3.3 The fee will only be paid in the currency (EUR) in which this contract is made.
- 3.4 The amount paid by ASHE is refundable when the travel and subsistence costs are less than the allowance made.

#### Article 4. Termination of the contract, Force majeure

The implementation of the external review can be terminated by either of the parties in the case of force majeure. Force majeure shall mean any exceptional, unforeseeable situation beyond the parties' control which might prevent either of them from performing their obligations under this contract. Neither of the parties can be considered liable for breach of the obligations under this contract if this has been due to a force majeure. Negligence, intentional action, defects in equipment or delays in its delivery, labour disputes, strikes or financial problems cannot be considered as a force majeure.

#### **Article 5. Amendments**

This contract is the entire agreement of the parties and may be amended only by written agreement.

#### **Annex 1: TERMS OF REFERENCE**

23 February 2011

#### 1. Background and Context

The Agency for Science and Higher Education\_(ASHE), established by the Croatian government in 2004 (Official Gazette 101/2004), is the quality assurance agency in Croatian science and higher education. The main mission of the Agency is to continuously support quality improvement of science and higher education, by applying European and international best practices. The Agency carries out a part of the procedure of initial accreditation, procedures of reaccreditation, thematic evaluation and audit, collects and processes data on Croatian higher education, science and related systems, which serve as a basis for analyses necessary to establish standards and criteria of evaluations carried out by the Agency, as well as a basis for informed and evidencebased strategic decision-making of bodies in the system of higher education and science. The Agency also provides information and unifies data on the conditions of enrolment in higher education institutions in the Republic of Croatia. One of the Agency tasks is to administer and support the activities of the National Council for Higher Education, National Council for Science, Council for Financing Scientific Activity and Higher Education, Ethics Committee in Science and Higher Education, 7 Area Councils, 22 Scientific Field Committees, Humanities and Arts Committees and expert panels.

The Agency is a full member of INQAAHE (International Network for Quality Assurance Agencies in Higher Education) and CEE Network (Network of Central and Eastern European Quality Assurance Agencies in Higher Education) as well as the OECD IMHE Forum (Organization for Economic Cooperation and Development – Programme for Institutional management in Higher Education).

ASHE has an associate status within ENQA (European Association for Quality Assurance in Higher Education) since December 20, 2007.

#### 2. Purpose and Scope of the Evaluation

The Management Board of ASHE has commissioned AGAE to conduct an external review of ASHE. This review is type B, as defined in the *Guidelines for External Reviews of Quality Assurance Agencies in the EHEA*. It will evaluate the way in which and to what extent ASHE fulfils the criteria for the ENQA membership and thus the *Standards and Guidelines for Quality Assurance in the European Higher Education Area*.

The review also aims at providing feedback on ASHE's role and tasks in the context of the Croatian higher education and science systems, as the main instrument for quality promotion and assurance carried out through all types of external evaluation of higher education institutions and scientific organizations in Croatia according to the Act on Quality Assurance in Science and Higher Education. Feedback from the review panel about these activities is useful to ASHE and helps to determine their effectiveness and whether they meet the set aims.

#### 3. The Review Process

The process will follow in general terms the ENQA policy on "ENQA-organised external reviews of member agencies".

The evaluation procedure will consist of the following steps:

- Nomination and appointment of the review team members;
- Self-evaluation by ASHE including the preparation of a self-evaluation report;
- A site visit by the panel of reviewers to ASHE;
- Preparation, completion and submission of the final evaluation report.

#### 3.1 Nomination and appointment of the review team members

The review panel will consist of six members: five external reviewers (two quality assurance experts, two representatives of higher education institutions, a student) and a review secretary. The members are totally independent of ASHE. The proposal of the expert panel with their respective curricula vitae will be submitted to ENQA by AGAE.

#### 3.2 Self-evaluation by ASHE, including the preparation of a self-evaluation report

ASHE is responsible for the execution and organisation of its own self-evaluation process and shall take into account the following guidance:

- Self-evaluation is organised as a project with a clearly defined schedule and includes all relevant internal and external stakeholders;
- The self-evaluation report is broken down by the topics of the evaluation: background description of the current situation of the Agency; analysis and appraisal of the current situation; proposals for improvement and measures already planned; a summary of perceived strengths and weaknesses;
- The report is well-structured, concise and comprehensively prepared. It clearly demonstrates the extent to which ASHE fulfils its tasks of external quality assurance and meets the criteria for the ENQA membership and thus the *European Standards and Guidelines*. The report will be submitted to the review panel a minimum of four weeks prior to the site visit.

#### 3.3 A Site Visit by the Review Panel

The review panel will draw up and publish a schedule of the site visit. ASHE shall be given at least one month's notice of the site visit schedule in order to properly organise the requested interviews. The schedule will include an indicative timetable of the meetings and other exercises to be undertaken by the review team during the site visit, the duration of which will be 2 days.

#### 3.4 Preparation and completion of the final evaluation report

On the basis of the review panel's findings, the review secretary will draft the report in consultation with the expert panel. The report will take into account the purpose and scope of the evaluation as defined under article 2. It will also provide a clear rationale for its findings. A draft will be submitted for comment to ASHE within four weeks of the site visit for comment on factual accuracy. If ASHE chooses to provide a statement in reference to the draft report it will be submitted to the chairperson of the review panel within two\_weeks after the receipt of the draft report. Thereafter the expert panel will take into account the statement by ASHE, finalise the document and submit it to ASHE and AGAE, which will submit it to the ENQA Secretariat for the attention of the Board.

The report is to be finalised within two months of the site visit and will not exceed 40 pages in length.

#### 4. Follow-up Process and Publication of the Report

ASHE will consider the expert panel's report and inform AGAE of its plans to implement any recommendations contained in the report. Subsequent to the discussion of the evaluation results and any planned implementation measures with AGAE, the review report and the follow-up plans agreed upon will be published on ASHE website.

#### 5. Budget

ASHE shall pay the following review related fees:

- Chair 5.000 EUR
- Review secretary 5.000 EUR
- Other panel members (4) 3.000 EUR
- Administrative overhead for AGAE 5.000 EUR
- Travel and subsistence expenses (approximate) 6.000 EUR

In the case that allowance for travel and subsistence expenses are exceeded, ASHE will cover any additional costs after the completion of the review.

The fees will be paid in two instalments – the first one, amounting to EUR 16.500, will be paid by May 10<sup>th</sup> 2011. The second one, amounting to approx. EUR 16.500, depending on the total travel and subsistence expenses, will be paid by November 1<sup>st</sup> 2011.

It is worth pointing out my contribution to the launching of two, nowadays nationally and internationally well respected, academic units at the University of Vigo: the Telecommunications School, in which I was part of the board of directors since the very first day of its activities back in 1985, and the Communication Technologies Department, nowadays split in two new Departments (Signal Theory and Communications and Telematics Engineering) with a Faculty number in excess of 50 Electrical Engineering Ph.Ds.

As far as the international projection is concerned, besides the presence in European projects and initiatives, I am particularly proud of my involvement in launching the ISTEC Consortium in 1990; as of today, ISTEC counts among its members more than 100 Universities from the US, Spain and the Americas, and some major IT industrial firms.

As President of the University of Vigo, I am particularly proud of the impulse given to the project of the new University Campus developed by the architect Enric Miralles. With an outstanding innovative component, this campus has received international (portrait of Global Architecture in 2004) as well as national recognition, Special Prize FAD 2004.

It is also worth mentioning the launching of the Scientific Park of the Galician Universities, and the agreement with the Ministerio de Ciencia y Tecnología to manage the funds awarded to the research teams in charge of studying the effects of the last oil spill in Galicia.
