The editors encourage the submission of research results, especially those that evaluate the impact of quality assurance systems, procedures and methodologies. Furthermore, theoretical analyses of quality assurance in higher education, comparative evaluations and analyses of international topics regarding policies and practices that focus on identifying methods, systems



and transferable best practices and on the participation of the stakeholders, in a broadest sense, at quality assurance in higher education are also welcomed.

Steps to follow in order to publish a paper in QAR:

- Send the paper (in editable and pdf format), edited according to the guidelines below, to the following e-mail address: [qar@aracis.ro](mailto:qar@aracis.ro), accompanied by an affidavit on originality (in pdf format) signed by all the authors, including the mention that the paper was not published before in another publication (see *Annex 1*).

Please specify the following author identification information in the paper and in the affidavit:

- *Name and Family Name;*
- *Status (Professor, Associate Professor, Lecturer, PhD candidate etc);*
- *Professional affiliation (name of the university/ institute etc);*
- *E-mail address;*
- *Phone number.*



- Together with the article, please also send a declaration signed by all authors (in pdf format), which specifies the name of the author who will carry the correspondence with QAR and which includes the *phone number* and *e-mail address of this author*. Any issues regarding the publishing of the article (such as clarifications, additions etc) will be discussed and addressed by QAR only with the author nominated to carry the correspondence (see Annex 2).

The editors will notify the *author* nominated to carry the correspondence regarding the receipt of the paper, the estimated date for the completion of the review process and its result.

The editors are responsible for formatting the paper according to the journals' template. Publishing academic papers in QAR is free of charge, and the author/first author receives a printed copy of the journal in which the paper was published.

### **Submission guidelines (obligatory):**

1. The submitted papers have to be original and unpublished. Papers which are too descriptive shall not be accepted.
2. The content of the paper has to be presented clearly and the authors' perspective has to be scientific and un-biased.
3. The submitted papers must be between 5000 and 6000 words long (including citations and reference list). Larger manuscripts are also taken into consideration but they may be published sequentially.
4. The submitted papers must include an abstract in Romanian (followed by maximum 6 keywords in Romanian) and an abstract in English (followed by maximum 6 keywords in English). Each abstract must be between 100 – 150 words long.
5. The submitted papers can be edited by the author in Romanian or English.
6. Body text: Times New Roman, size 12 points, justified, 1.5 lines. Titles: Times New Roman, size 14 points, Bold. Subtitles: Times New Roman, size 12 points, Bold.
7. Reference list and citations must follow the author-date-reference system of the Chicago Manual of Style (16th Edition):
