Transnational education is a huge business globally, and is growing. But who guarantees the quality of the experience of students? Who checks that the education in the 'receiving' country is delivered to the same standard as that at the 'home' campus? This session will explore the existing tools for quality assurance of transnational education, barriers for their use, and make suggestions regarding the role of quality assurance agencies in protecting interests of students and the role of inter-agency cooperation in building trust in transnational education.
