

Legislative alignment with the ESG: the path towards meeting the Bologna Process key commitment on quality assurance in the Western Balkans

Ministerial and QA agency representatives' meeting in conjunction with the kick-off meeting of

Quality assurance is a key feature in developing mutual trust and in increasing mobility and fair recognition of qualifications and study periods throughout Europe. As stated in the Paris Communiqué¹ by the Ministers of Higher Education in the European Higher Education Area (EHEA) in 2018, quality assurance is and remains one of the pillars of the EHEA. Having a quality assurance system in compliance with the Standards and Guidelines for Quality Assurance in the EHEA (the ESG²), with regular external quality assurance performed by EQAR-registered agencies, is therefore a key commitment of the Bologna Process.

Several countries in Western Balkans³ do not yet have an independent quality assurance agency or the agency is not yet in compliance with all aspects of the ESG. To foster the implementation of this key commitment in the region, the European Association for Quality Assurance in Higher Education (ENQA) and the European Quality Assurance Register for Higher Education (EQAR⁴) organise a meeting of ministry and QA agency representatives with responsibility for higher education in the Western Balkans, titled 'Legislative alignment with the ESG: the path toward meeting the Bologna Process key commitment on quality assurance'. Ministry and QA agency representatives of Slovenia and Croatia are also invited, due to the shared characteristics of quality assurance and higher education systems and their experience in supporting national QA agencies to reach ESG compliance.

The meeting will be held on 8-9 March 2023 in Brussels, Belgium. It **aims to promote the importance of the ESG as a shared European commitment and discuss the conditions needed to achieve this**. Special attention will be given to discussing the role the legislative framework to support this. Furthermore, the meeting hopes to build bridges, and stimulate sharing

Note: Kosovo is not in the EHEA but are committed to aligning with the ESG.

of experience between quality assurance and higher education systems in the wider region. The meeting will be held in conjunction with the kick-off meeting of the SEQA-ESG⁵ project, to link the discussion to the upcoming activities on this in four countries that are partners in this project, two of which are from the Western Balkans (Azerbaijan, Bosnia and Herzegovina, Serbia, Ukraine).

The first round of the SEQA-ESG project was implemented in years 2020-2022 and aimed to support QA agencies and national authorities in six countries (Albania, the Czech Republic, Malta, Moldova, Montenegro, and Slovakia) to create an ESG-compliant QA system. The upcoming second round, SEQA-ESG2 will bring together QA agencies from another four countries in reaching the same goal. To meet the objectives of this meeting, ministry and QA agency partners from the first round of the project will be invited to join the meeting and share experience in overcoming obstacles when addressing system/legal, organisational and practice-related challenges in complying with the ESG. Ministry representatives from Azerbaijan and Ukraine will be invited to shadow the meeting due to their QA agencies' involvement in SEQA-ESG2.
